Rules for the NYS USBC, Inc., 2022 Annual Meeting

- 1. Roberts Rules of Order Newly Revised shall govern the procedures for the Board of Directors and Delegates at this Annual Meeting, provided they do not conflict with the Bylaws of the New York State USBC, Inc.
- 2. The meeting shall convene at 12:00 pm, Saturday, June 11, 2022.
- 3. Delegates shall be logged-in and "on their lane" at least five minutes prior to the scheduled starting time. Please don't switch lanes during the presentations.
- 4. Delegates must mute their microphones during presentations. Cameras are optional, keep them on if you prefer.
- 5. The second reading of Credentials is given prior to the Legislative Report.
- 6. To be recognized, a Delegate shall advance to a microphone to address the Chair. The Delegate's full name shall be clearly stated along with the association represented, Adult or Youth.
- 7. A Delegate shall be permitted to speak only *twice* on any question, limiting each discussion to *two* minutes. The exception to this rule is at the discretion of the Chair.
- 8. All motions shall be stated in the affirmative.
- 9. All motions should be in writing and submitted in advance to the Chair.
- 10. The use of cell phones and beepers, making or receiving calls, is prohibited while the meeting is in session.
- 11. To expedite the business of the meeting, Delegates shall give courteous and full attention to the Speaker having the floor.
- 12. The Chair may call an intermission during the session.
- 13. The Chair may deviate from the agenda.
- 14. Exceptions to these rules may be made at the discretion of the Chair.

The Committee moves acceptance of these rules.

Report of the NYS USBC Office

Greetings Fellow Bowlers,

Welcome to Utica, it's great to see everyone in this room and not on a screen like last year. The USBC National Convention had a slogan "Together Again." I think that fits us too.

This year we saw more people returning the lanes, as we are starting to rebound from the Pandemic, Adult membership as of May 1 was 51,893 which is up more than 8,000 from last year. Youth membership is 6302 also up 500 bowlers from last year. We are still short of our pre-pandemic numbers but we are headed in the right direction.

New York State had a good year on the national scene, a team from Greater Buffalo USBC won the Team All-Events Title at the USBC Open Championships in 2021. The team Bowl U consisted of Kevin Bienko (2,226), Chad Mee (2,042), Andrew Herbert (2,086), Ryan Reese (1,929) and Joseph DiNardo (1,675) for a 9,958 total.

The USBC Hall of Fame Class of 2020 was finally inducted after two-year hiatus, Patrick Allen, Westchester County and Patrick Healy, Niagara Falls, were inducted for Superior Performance. While Jim Zebehazy, a Buffalo Native, who is synonymous with Junior Gold and the Registered Volunteer Program was inducted for Meritorious Service.

We had a women's team chosen as Grand Marshall's for their Squad at the USBC Women's Championship, those bowlers included Kathleen Leipold, Karen Brouwere, Melissa M. Potoeski, and Cheryl Rice. This team is from the Corning USBC.

All of our tournaments saw an increase in participation from last year as we are getting closer to the pre-pandemic levels. We will also return to Long Island in 2023 with the Masters slated for Herrill Lanes in New Hyde Park. The LIUSBC currently 6770 member which is the largest in the state.

The Women's Championships will also return to the popular Schneider's Fishkill Bowl in 2024 and the Queens will be a new location Spins Bowl Carmel. We are also headed to Lucky Strike Lanes in Malone and Broadway Lanes in Fort Edward for the first time. Both centers have hosted Youth Events over the years which were always successful.

The Youth Committee has a few people retiring this year who have played a big part in Youth Bowling in New York for decades. Their dedication to the kids can't be matched, to quote Michael Jordan, "You can wear the shoes but you can't fill them." Thank you, Mike Callan, Kathy Larson and Mathew Hardy. The biggest thanks goes to Paul Terracciano who has been the Tournament Manager for the Adult Youth Tournament. I have been privileged to know Paul since I was 3 years old and consider him a good friend. You will all be missed.

In closing I would like to thank the bowlers in the state who have helped during this transition. We have all learned from each other and I hope to continue the open dialog with all the bowlers in the state.

I would like to see new centers and regions of the state host more of our tournaments. If you have a center in your area who would like to have a State Championship in their building please let me know. Report of the Legislative Committee Legislative Committee Report

Several changes to the NYS USBC Bylaws are required due to changes made by USBC. These changes revolve around the elimination of the term Youth Directors and the time limit for submitting applications to run for positions from the floor for the Board of Director and Board officers prior to the annual meeting.

The mandated changes for elimination of the term Youth Director, and requirement for 20% of the board to be directors representing youth, have already been incorporated in the NYS USBC Bylaws. They can be found in:

- 1. Article V: Board of Directors Management Section A: Board Composition, Authority and Duties
- 2. Article V: Board of Directors Management Section B: Eligibility
- 3. Article VII: Meetings Section A: Annual Meeting

The following mandated change was made by USBC concerning qualifications for Nominations from the floor for both Directors and Officers.

Qualifications must be submitted, in writing, at least 24 hours, or up to seven (7) days prior to the opening of the annual meeting as determined by the delegates. Qualifications are due **24 Hours** prior to the opening of the Annual Meeting.

The Board of Directors proposes that this be changed to 7 days to allow for proper review of qualifications prior to the annual meeting as allowed by USBC

Qualifications must be submitted, in writing, at least 24 hours, or up to seven (7) days prior to the opening of the annual meeting as determined by the delegates. Qualifications are due **7 Days** prior to the opening of the Annual Meeting.

Due to the elimination of the term Youth Directors at the State and Local levels in accordance with USBC mandates the board also proposes a change in Quorum for the Annual meeting.

Current text in Article VII: Meetings Section A: Annual Meeting

7. Quorum.

The Board, Adult Delegates representing Adult members and Youth Delegates determine the number.

- a. Twenty-Five (25) Adult Delegates representing adult membership constitute a quorum.
- b. Fifteen (15) Youth Delegates constitute a quorum for Youth.

Revised Text

7. Quorum. 40 board members constitute a quorum. The board and delegates determine the number.

Independent Accountant's Review Report

Report of the Awards Committee

The awards committee unanimously selected the following individuals to receive awards at our Hall of Fame dinner on June 11, 2022 in Binghamton.

Susan "Sue" Jerzioski (Superior Performance) Jeziorski from Cheektowaga, a long-time bowling coach, has an extensive resume for local, state and national tournaments. She has six 300 games and six 800 series. At the local level in Buffalo, she is a nine-time team and five-time doubles champion in the Women's Tournament. She was Bowler of the Year in 2004 & 2007, Buffalo City Queens Champion 1991 and a member of the Greater Buffalo USBC Hall of Fame. In New York State events, Jeziorski is Queens Champion 2003; Highest Women's Average in New York State 2001-2002 and 2010-2011 Seasons; Women's Team, Doubles and All-Events Champion 2004, NYS Team USA Champion 1994 and Bronze Medal Winner at the Empire State Games 1994 where she also had the highest series for both men and women in all events. She also won a few titles at the Women's National Tournament capturing the Doubles Title in 2007 and 2010. Her team also rolled the highest score for a five-person team with a 3424 in 2010. Jeziorski won the Bowlers Journal International Doubles Champion 2003 and three times had the high highest doubles game in the country.

William "Bill" C. Hasiotis (Superior Performance) Hasiotis, who hails from Rochester, began his route to the Hall of Fame as a Collegiate Bowler at the Rochester Institute of Technology. He had a team high average 1983-84; Coca-Cola Collegiate Invitational Doubles Champion 1983; Mohawk Valley Collegiate Invitational Doubles Champion 1985; and ACUI Regional Team Champion 1986. While bowling in Rochester, Hasiotis was the Senior Master Champion in 2017 & 2019; Rochester Association Tournament Team Champion three times, Doubles Champion two times and one singles title. He also won the Canandaigua Masters Title in 2016 & 2017. He was part of the Scratch Team Champion in the New York Open Tournament in 2015, 2016, 2019 & 2021, they also captured the Handicap Title in 2015. In 2014 Hasiotis finished second in the Open Doubles Division.

Nelson Chase (Meritorious Service) Chase calls Hudson Falls home and is a key member of the New York State Youth Committee. For the more than 20 years, he has been the Tournament Manager for the State Pepsi Scholarship Tournament, which has awarded over \$500,000 in scholarships to the youth in New York. He has been a youth coach at Broadway Lanes for 20 years and Fort Edwards High School Bowling Coach for 30 years. Chase is the President of the Adirondack USBC and a member of their Hall of Fame.

Benjamin "Ben" T. Amberge (Meritorious Service) Amberge comes from Vestal, he is currently the Association Manager for the Southern Tier USBC since 2008, where he has donated his time never accepting a salary. He was elected to their Hall of Fame for Meritorious Service in 2008. He has been a delegate for both the State and National Conventions for more than 15 years. He has also been a member of the lane inspection crew and Secretary/ Treasurer for the Kyle Shaeffer Memorial League at Ideal Bowling Center for the last 15 years. He rolled five 300 games, one 800 series and high average of 226.

<u>Paul Terracciano</u> (Service to Youth) Terracciano, a longtime resident of Hawthorne has been involved with youth bowlers over 30 years. He was coach with the White Plains Juniors, part of the Westchester County JBT Program and Westchester USBC Youth Committee for the same time period. Paul has been a volunteer at the New York State Adult Junior Tournament since it's inception in 1999, becoming Tournament Manager in 2012. In addition, he has also managed the processing of the scores for the Youth Team Finals for the last 25 years.

Connie Hladik (Service to Bowling). Hladik is from Johnstown and has been the Association Manager from the Fulton County USBC for more than 10 years, she served as a Delegate at the State Convention for 10 years and twice for the National Convention. She has been secretary of local bowling leagues for over 40 years and director for local tournaments for more than 15 years.

Report of the Tournament Committee

This season saw a return to the full schedule coming off the pandemic. All our tournaments ran on schedule with little to no restrictions on the centers. We were back on business and hit the ground running with our first event in August. Once again, we received \$10,000 from Bowl TV to add to our prize fund for all tournaments We activity looking for centers to host events staring in 2024. If you know if any centers who would like to host an event please reach out to our office.

Following is a summary of tournaments from the 2021-22 bowling season:

Women's Seniors Singles, Rose Bowl Lanes, Canandaigua, August 13-15, 20-22 2021 — A total of 307 women came for this event, this was down about 98 bowlers from 2019. The tournament was cancelled in 2020. The 2022 tournament is scheduled for Lighthouse Lanes in Oswego, August 19-21 & 26-28.

Open Senior Singles, Vista Bowling Center, Yorkville, October 16-17, 23-24 2021 — A total of 162 doubles teams and 88 singles competed in the two-weekend Doubles & Singles tournament. Entries were up approximately 30% from last year. The 2022 tournament is scheduled for Spins Bowl Wappingers Falls October 15-16, 22-23.

Senior Masters, Doug Kent's Rose Bowl Lanes, Newark November 5, 2021 — Patrick Brick (Tonawanda USBC) defeated Rich Strath (Schenectady USBC), 498-434, in the two-game finals to claim the \$750 first place prize. The tournament drew 60 entries, which was up from the 44 bowlers last year. The 2022 event is scheduled for November 5 at Allie Brandt Lanes in Lockport

Masters, AMF Dewey Garden Lanes, Rochester, March 5, 2022. Dan Vick (Rochester USBC) defeated Alex Cavagnaro (Westchester County USBC) 492-432 in the two-game finals to win the \$2,000 top prize and free entry to the 2023 USBC Masters. This was his second NYS Masters Title. The tournament drew 116 bowlers, four less last year. The 2023 the Masters will see a return to Long Island as we head to Herrill Lanes in New Hyde Park on March 4.

Queens, Ripic's Carousel Lanes, Binghamton, NY, April 2021. In the Open Division Jenny Close (Central NY USBC) defeated Liz Johnosn (Greater Buffalo USBC) 244 – 208 to capture her first title, winning \$900 for first place and a paid entry to the 2023 USBC Queens. In the Classified Division Angelina Tati (Kingston USBC) defeated Alexandra Talerico (Rome NY USBC) 179 – 137 to earn \$650. Tati is a youth bowler she will receive a scholarship in lieu of prize money. We had 94 bowlers this year which was up from the 79 in 2021. The 2023 the Queens is scheduled for April 15 at Flamingo Bowl in Liverpool.

Open Championships, Spare Time, Latham, April 9 thru May 15, 2022 – Entries were up from previous year and we filled the house for a bunch of squads. We had 209 teams (up 19%), 454 doubles (up 12%), 908 singles (up 12%) and 751 All-Events (up 13%). The 2023 the Open Championships are scheduled for April 1 thru May 7 at Bowl-A Rolls Lanes in Rochester.

Women's Championships, Midway Lanes, Vista, April 9 thru May 22. 2022 – Entries were up from last year. We had 232 teams (up 36%), 451 doubles (up 32%), 902 singles (up 32%) and 883 All-Events (up 38%). The 2023 Women's Championships are scheduled for April 1 thru April 23 and May 19-21 at AMF Strike and Spare Lanes in Syracuse.

Report of the Youth Committee

New York State Pepsi Championships (Nelson Chase, State Tournament Manger)

In the NYS Youth Pepsi (Singles) Tournament, 5,664 bowlers participated in in-league qualifying and 1,955 in the regionals across the state. Each of these totals is at least 30% more than 2020-2021.

At the state finals in Rome on April 23, a staff of 16 Youth Committee members and volunteers processed 117 bowlers across the U12, U15, and U18 squads throughout the day. The state finals had one bowler "no call no show" and one get injured during practice and could not participate. Thank you to everyone that worked to make our day go smoothly.

With an influx of money from National and expired unallocated funds to be redistributed, the State Finals scholarships broke down as follows: 1st: \$2,000, 2nd \$1,000, 3rd \$500, 4th \$400, 5th \$300, and every other bowler 6th thru last \$200 each. This has never happened at Pepsi...every state finalist that bowled received a scholarship.

In summary, nearly 200 Pepsi scholarships were awarded this season...totaling \$71,500. The complete list of scholarship winners has been submitted for processing in SMART. Regional and State Finals results, by division, are posted to bowlny.com.

State Youth Committee Meeting

Our State Youth Committee meeting was held on Friday April 29th at the Liverpool Ramada Inn. Discussions were held on increasing the participation for the regional team events.
