Rules for the NYS USBC, Inc., 2025 Annual Meeting

1. *Roberts Rules of Order Newly Revised* shall govern the procedures for the Board of Directors and Delegates at this Annual Meeting, provided they do not conflict with the Bylaws of the New York State USBC, Inc.
2. The meeting shall convene at 1:00 pm, Saturday, June 28, 2025.
3. Delegates shall be seated at least five minutes prior to the scheduled starting time. Please don't change seats during the presentations.
4. Delegates must mute their cell phones during presentations.
5. The second reading of Credentials is given prior to the Legislative Report.
6. To be recognized, a Delegate shall advance to a microphone to address the Chair. The Delegate's full name shall be clearly stated along with the association represented.
7. A Delegate shall be permitted to speak only *twice* on any question, limiting each discussion to *two* minutes. The exception to this rule is at the discretion of the Chair.
8. All motions shall be stated in the affirmative.
9. All motions should be in writing and submitted in advance to the Chair.
10. The use of cell phones, making or receiving calls, is prohibited while the meeting is in session.
11. To expedite the business of the meeting, Delegates shall give courteous and full attention to the Speaker having the floor.
12. The Chair may call an intermission during the session.
13. The Chair may deviate from the agenda.
14. Exceptions to these rules may be made at the discretion of the Chair.

ROGER BUCKMAN, CHAIR

REPORT OF THE FINANCE COMMITTEE

TO: NYS Board of Directors and Delegates assembled at the 14th Annual Meeting of the New York State USBC, Inc. held June 28, 2025, at DoubleTree by Hilton Syracuse – 6301 State Route 298, East Syracuse, New York, 13057

The Finance Committee met on December 8, 2024. The team reviewed past P & L reports and prepared a proposed budget for the fiscal year 2024 – 2025 which gained approval at the Board of Directors meeting in December 2024.

Pathways generated \$25,906 last year. The committee proposed to the board that we add \$94.00 to bring the total to \$26,000 and distribute as follows. (This proposal gained approval at the December Board meeting).

- \$10,000 to Sloan Kettering
- \$10,000 to Roswell Park
- \$3,000 to the NYS scholarship funds
- \$3,000 to BVL

The committee met again on January 25, 2025, at DoubleTree Binghamton to conduct an internal financial audit of the New York State USBC. Results and discoveries of that audit are identified as follows:

- The 990 IRS forms reviewed at our audit meeting were for fiscal years 8/1/2019 - 7/31/2022, the forms were filed electronically on 12/8/2000 and 11/15/2022. Other years were done similarly and were to the satisfaction of the committee.

- Reviewed reconciliation statements for all accounts and everything matched and was satisfactory to the committee.

- A discovery was that the President has not been signing the reconciliation statements but has been reviewing and approving them. President and Association Manager will sign them in the future to reduce any issues with bonding.

- Credit card statements matched the invoices as presented – no issues.

- 1099 review done on random members from 2021 – 2024.

- Tournament 1099's are determined by a report from WinLabs when the cumulative amount is \$600 and above.

- All the tournament payouts we reviewed met the requirements.

- A finding discovered the non-issuance of a 1099 for a stipend amount of \$600. It was determined that a misunderstanding of the dollar requirement on Association Manager's part led to the non-issuance of 1099. This will be rectified and will not happen in the future.

- Board member expense reports and payment records randomly selected over three years were accurate and complete.

- A discovery revealed that the year-end annual delegates financial reports (from annual program book) for 2021 – 2024 were not consistent from year to year. This was a result of copying and pasting data, lack of review before going to print and not having complete records prior to going to print.

- A discovery found pertaining to Association Manager salary distribution.

- Sixty percent should come from the tournament account and 40% from the general account. This has been paid in reverse over the last two years, which led to an approximate \$10,000 error. This has been corrected moving forward.

As a result of this audit, all fiduciary responsibilities are met, and your association is in sound financial order. The full financial disclosure can be found further in the annual program and discussed by Angelo, in detail later in the meeting.

Report of the Tournament Committee

This year the New York State USBC had a mixed year, after record turnout at two of our tournaments from the previous season, some events up and some were down our typical turnout. BowlTV was our big sponsor again they provided \$10,000 to enhance the tournament prize fund. More team captains have been using online registration, all tournaments except the Women's Senior Singles are now on the portal. We are looking for centers to host tournaments beginning 2027 if you have a center in your association who would like to host an event please contact Angelo Corradino, association manager.

Following is a summary of tournaments from the 2024-25 bowling season:

Women's Seniors Singles, Jefferson Valley Lanes August 9-11, 16-18 2024 — A total of 228 women came for this event, we were down from 2023. **The 2025 tournament is scheduled for Lucky Strike Lanes in Malone August 8-10 & 15-16**

Open Senior Singles, Ideal Bowling Center Bowl, Endicott October 12-13, 19-20, 2024 — A total of 101 Doubles teams and 183 Singles competed in the two-weekend Doubles & Singles tournament. This was slightly below our typical draw. **The 2025 tournament is scheduled for Lakeview Lanes, Fulton October 11-12, 18-19, 2025.**

Senior Masters, Owego Bowl, Owego November 2, 2024 — Patrick Brick (Tonawanda USBC) defeated Gary Reynolds (Finger Lakes NY USBC), 433-418. This was his second Senior Masters Title. The tournament drew 59 entries, down just one bowler from last year. **The 2025 event is scheduled for Broadway Lanes in Fort Edward, date to be determined based on PBA50 Schedule**

Masters, Ripic's Carousel Lanes, Binghamton, March 1, 2025. Dan Vick (Rochester NY USBC) defeated Alex Cavangaro (Westchester County USBC) 438-434 in the two-game finals to win the \$2,000 top prize and free entry to the 2026 USBC Masters. This was his third NYS Masters Title. The tournament drew 118 bowlers, the same as last year. **The 2026 the Masters is heading to Pat Tarsio's Lanes in Newburgh on March 7, 2026.**

Queens, Sportsman's Bowl, Schenectady, April 12, 2025. In the Open Division Shannon Sellens (Long Island USBC) defeated Suzanne Morine (Schenectady USBC) 224 – 194 to capture her impressive fifth title, winning \$900 for first place and a paid entry to the 2026 USBC Queens. In the Classified Division Shannon Guernsey (Central NY USBC) defeated defending champ Angelina Tati (Kingston USBC) 259 – 217 to earn \$800. We had 104 bowlers this year which matched last year's total. **The 2026 Queens is scheduled for April 11 at Crystal Lanes in Corning**

Open Championships, Kingpin's Family Fun Center South Glens Falls, April 26 thru June 15, 2024 – We had 241 teams (up 32), 573 doubles (up 124), 1146 singles (up 248) and 992 All-Events (up 210) **The 2026 Open Championships are scheduled for April 24 thru June 7, 2026 at Patel's Kingston Lanes.**

Women's Championships, Kingpin's Family Fun Center Latham, April 11 thru May 25, 2025 – Entries were down from last year about 6%. We had 241 teams, 470 Doubles, 940 Singles and 876 All-Events. **The 2026 Women's Championships are scheduled for April 10 thru May 17 at Valley Bowling Center in Waverly.**

Pepsi Report

League level qualifiers to regionals increased by 6 bowlers.

Actual bowlers at regionals declined by 79 bowlers (no shows increased).

There was "perfect attendance" of 120 bowlers at State Finals in Rome.

\$46,000 total scholarship fund for 2025. U8 & U10 each received \$200 for 1st and \$100 for 2nd.

State finals places: 1st: \$1,500, 2nd \$750, 3rd \$500, 4th \$400, 5th: \$300, 6th-20th \$150 each.

King Pin Lanes & staff did another fine job of hosting the state finals for a 20th consecutive year.

The picture sales, money & ball raffles were a huge success.

2026 changes: No more "Pepsi"... No more "Pepsi shirt" to state finalists.

The "Youth Scratch Championships presented by SMART" will be the new name using the same format.

No more U15 division. Creating new U14 & U16 divisions.

The state finals will be in Rome April 18: U12 & U14's first squad, U16 & U18's second squad.

Advancement fee to regionals will increase \$1 to generate scholarship money for the added division.

Team Report

364 teams at regionals saw a decrease of 15 teams. The goal for next season is 500 regional teams.

\$9,900 to 19 of the 69 teams at State Finals in Syracuse.

State finals places: 1st: \$1,000 2nd: 600 3rd \$400 4th: \$300 5th \$200 per team in handicap divisions.

Only 1st thru 3rd in scratch. (Except there was a tie.)

51 individual award plaques went to high games and series by age/gender.

There were MULTIPLE honor/high scores rolled including two 300 games.

Strike N Spare Lanes & staff did another fine job of hosting the state finals..into the 5th decade.

14 door prizes were awarded between the two squads. The picture sales, money & ball raffles were a huge

Youth Leaders did an excellent job as color guard and as tournament score takers, runners, and "officials".

2026 changes: Redistribute teams by team average classification: Class A 700-900, Class B 550-649,

Class C 549 and under. The new team classifications were based on the distribution of averages of the 70

teams registered to bowl in Syracuse this season. Across the state, using the current team divisions, there are

very few Class C teams and a very large number of Class B teams, by comparison. The state finals will be in

Syracuse May 2, 2026.

Ad Books Report

The Pepsi book profited \$1,713 and the Team book profited \$1,649. Thank you to Tom Solimine & Sandy Aitchison for their continued efforts. Changes for 2026: With increased printing costs, the prices of full, half, and quarter page ads will be increased, patron ads will be eliminated, and "name only" boosters will remain \$1.
